### What are "Cookies" and how do we use them?

 Adriatic Lending Solutions uses "Cookies" to track and record your preferences and activity on our Web site. Cookies are small bits of data that are sent to your browser and stored on your computer's hard drive. Your cookie may be set at various times during your interaction with our Web site.
